

PROGRAMS of the 112 centers operating nationally:

93% provide infant care
21% provide kindergarten (state-approved) programs
54% provide drop-in/emergency care
36% provide summer programs for school-age children
21% provide before/after school programs
2% provide moderately sick child care

ACCREDITATION

by the National Association for the Education of Young Children (NAEYC)

86% of eligible centers are currently accredited

OPERATING HOURS

84% of the centers are open 11 or more hours per day Open hours range from 10 to 13 hours per day

7,799 children enrolled nationally

LEVELS & EXPERIENCE

1,708 full-time and 298 part-time staff are employed in our centers

ASSISTANCE

- Because the cost of high quality care is not affordable for many families even when the government provides space and equipment tuition assistance is critical.
- Centers reported a total of \$1,027,386 was distributed from a variety of sources \$314,858 from Combined Federal Campaign/United Way contributions and the balance primarily from state funds, recycle funds or fundraising events run by the boards of directors. 100% of the centers offer a tuition assistance program.
- 2,163 families received some form of tuition assistance at some time between October 2001 and September 2002.
- 243 Federal families received tuition assistance from their agency under the subsidy program for Federal employees.
- 60 centers received Combined Federal Campaign and/or United Way contributions.
- Grant money, used for training and special programs to enhance quality, also directly or indirectly affected the cost of care for parents.
- 14 centers received non-Federal grants.
- 41 centers participated in the USDA Food Program.
