The conference will begin Tuesday afternoon with meetings with Regional Child Care Coordinators and the Welcome Reception and Cornerstone Awards. There will be breakout sessions and a luncheon on the 9th and 10th with the conference ending at 5 PM on July 10. Timothy R. Shope, MD, MPH will conduct a general session fighting the war on germs: "Spit Happens."

Tours of the new San Francisco Federal Building are being built into the conference schedule. Tours will require Government issued picture identification with individual's names pre-vetted for security reasons.

#### The Process of Accreditation

#### A Teacher's View

This year has been one of the most meaningful years for me as the staff worked toward achieving national accreditation. Accreditation is not something that is achieved in a short period of time. It is a process that can take more than a year to complete. Even though I have been through this process several times before, this time was different. The standards seemed much higher and as a staff we put a lot more work into meeting certain goals than we ever had before

In the fall of 2005 each classroom started evaluating their area. In the toddler program when we went over the required criteria we were initially pleased to realize we were already meeting most of the criteria. In the summer of 2006 we started having frequent classroom meetings. The two toddler rooms met together and decided the main goal we needed to focus on was bringing more culture into the classrooms. We felt the best way to do this was by getting to know more about the families in our classroom. In the fall of 2006 we implemented tooth brushing into our daily routine. At first this seemed like an entirely big deal. We wondered how we were going to fit it into our after lunch routine. How would we possibly get all those teeth brushed on top of everything else that needed to be done? We adjusted the routine as needed and soon it felt like something we had always done.

In 2007 we changed our way of lesson planning as we learned about the Creative Curriculum. Each week we set individual goals for the children and based our activities on their needs, strengths, and interests. The Creative Curriculum also includes formally assessing the children several times each year. This has been another new criteria which took time for us to learn and implement.

As we approached summer we knew that we would have to provide some sort of portfolio for accreditation, but didn't know what it would entail. We started taking pictures of everything we were doing; art activities, music time, children playing, etc. Eventually we found out what was required. I have to admit I was overwhelmed at first. The portfolio needed to include evidence for a thick packet of criteria. As teachers we needed to have evidence to prove that we were meeting each criteria. Evidence includes. pictures, lesson plans, letters to families, etc. Puttina together the portfolio was one of the biggest jobs I have had to do. I haven't worked so hard since college. Yet in the end, once it was completed, the portfolio has become a great source of pride for me. It made me really stop and think about everything my co-worker and I were doing in our classroom. We couldn't just say we were doing something in our room. We had to prove it.

The last step in the accreditation process was preparing for the validation visit. We spent a lot of time talking about what it would be like when the validator came. Finally it was the A Director's Thank You

With great trepidation, little confidence and assorted moments of anger, confusion and hopelessness, we all began this journey toward accreditation. Initially, there were blank stares and frustration until we all realized that there really was no right way to approach this endeavor. As we waded through the paperwork and just decided to do it...in our own way and making up the rules as we went... the terror receded and determination took root. We realized that working together, sharing ideas and methods helped. Teamwork became the vehicle of survival. We turned to one another with questions and answers. "I" became "we" and it was "us" against "them" as we tried to outsmart those who created the uncharted territory we were traveling.

At long last, the day arrived when judgment would occur. We were confident in our abilities, but would the assessor see us in the same light??? Would something unexpected occur? Would one of us inadvertently do something wrong? For those who were observed, it was stressful but rewarding that all the work was examined. For those who were not, there was relief, but also disappointment that all the work was unexamined. It appeared that all went well, but we couldn't be sure, and so the waiting game began...until the New Year brought news that, indeed, success was ours.

#### "A job worth doing is worth doing together"

Working toward accreditation was a group effort. In particular, teachers went above and beyond to assemble the required classroom portfolios and assure that their rooms met the criteria. Many hours of personal time went toward assuring success, as well as additional hours at FCC. While this was occurring, assistant teachers and floaters manned the classrooms, carrying more of the classroom responsibilities. They supported the teachers and assisted in many ways. While we all found the process frustrating and laborious, it did indeed call forth teamwork and bring out the very best in all of us!

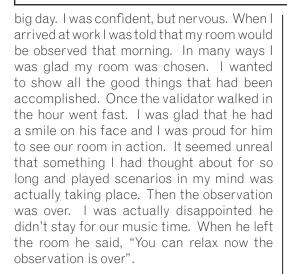
