A search of NCSA content can be penomed using the NHTSA Search Engine. When looking specifically for NCSA data files, reports, research notes, manuals, etc. remember that using a few simple search techniques can greatly improve the odds of producing the desired results. In general terms, using NCSA as part of your search will target that search to NCSA content. In addition, using key phrases to identify the subject matter will further pinpoint data and publications you may be looking for. For example, if you are looking for information regarding Child Restraints released by NCSA, you could use any one of the following:

SEARCH TEXT	SEARCH RESULTS
Child Restraint	Will return the greatest number of links. Returns from all of NHTSA content.
Child Restraints	Will return a different number of links than example above.
"Child Restraint" NCSA	Will return smaller, more specific number of links and will target NCSA content




Since 1972, NCSA's Special Crash Investigations (SCI) Program has provided NHTSA with the most in depth and detailed level of crash investigation data collected by the agency. The data collected ranges from basic data maintained in routine police and insurance crash reports to comprehensive data from special reports by professional crash investigation teams. Hundreds of data elements relevant to the vehicle, occupants, injury mechanisms, roadway, and safety systems involved are collected for each of the over 200 crashes designated for study annually.


SCI cases are intended to be an anecdotal data set useful for examining special crash circumstances or outcomes from an engineering perspective. The benefit of this program lies in its ability to locate unique real-world crashes anywhere in

the country, and perform in depth clinical investigations in a timely manner which can be utilized by the automotive safety community to improve the performance of its state-of-the-art safety systems. Individual and select groups of cases have triggered both individual companies and the industry as a whole to improve the safety performance of motor vehicles, including passenger cars, light trucks, or school buses.






## State Data Program (SDS, MMUCC, CODES)

New Mexico, North Carolina, Ohio, Pennsylvania, Texas, Utah, Virginia, Washington. South Carolina joined the State Data System in January 2003 and NHTSA is actively seeking additional members. NHTSA's goal is to have all states participate in the State Data System.

Crash statistics are presented in ten sections. General information can be found in the first three sections: Crashes, Vehicles, and People. The remaining sections focus on more specific data subsets. Sections 4 and 5 present alcohol- and speeding-related crash summary data. Specific vehicle actions and types are presented in Sections 6-8 (Rollovers, Motorcycles, and Large Trucks). Finally, Section 9 provides additional information regarding the ages of persons who were killed and injured, while Section 10 focuses on vehicle safety equipment.

State data availability, to include vehicle identification number (VIN) availability, is provided in Appendix A. Other state-specific information is given in the appendices B-G.
