## RESPONDENTS' MEMORANDUM IN SUPPORT OF THEIR MOTION FOR IN CAMERA TREATMENT OF TRIAL EXHIBITS

Pursuant to Rule 3.45 of the Federal Trade Commission's Rules of Adjudicative Practice and Paragraph 7 of the Scheduling Order, Respondents OSF Healthcare System ("OSF") and Rockford Health System ("RHS"), submit this Memorandum in Support of their Motion for In Camera Treatment of Certain Proposed Trial Exhibits. These exhibits are identified in Tables 1 and 2 in Support of Respondents' Motion for In Camera Treatment, and described in the accompanying declarations of Henry M. Seybold, Jr. and Robert Sehring.

Respondents seek in camera treatment of these exhibits because they are confidential, competitively sensitive documents that relate to OSF's and RHS' business strategy, payor contracting, and present and future operations. Public disclosure of these documents would result in clearly defined, serious competitive injury to Respondents. For all exhibits listed in Table 1, the information contained within is 1) not known to the public generally, 2) reflects strategic decision-making of senior executives from OSF or RHS, 3) is carefully guarded by OSF or RHS to maintain secrecy, 4) would benefit competitor hospitals if disclosed, 5) is the result of significant resources expended by OSF or RHS, and 6) would be difficult for another party to
replicate. Counsel for Respondents have carefully reviewed each and every exhibit identified in Table 1 and have determined that the exhibits meet the standards for in camera treatment, as set forth in Rule 3.45 and in Paragraph 7 of the Scheduling Order.

## I. The Clearly Defined, Serious Injury Standard

An applicant may receive in camera treatment of material offered into evidence when "its public disclosure will likely result in a clearly defined, serious injury." 16 C.F.R. § 3.45(b). In other words, "requests for in camera treatment must show 'that the public disclosure of the documentary evidence will result in a clearly defined, serious injury to the person or corporation whose records are involved.'" In re Kaiser Aluminum \& Chem. Corp., 103 F.T.C. 500, at *1 (May 25, 1984) (citation omitted). An applicant can meet that standard by establishing that the evidence is "sufficiently secret and sufficiently material to the applicant's business that disclosure would result in serious competitive injury." See In the Matter of Evanston Northwestern Healthcare Corp., 2005 F.T.C. LEXIS 27, at *1 (Feb. 9, 2005) (citation omitted). Further, the Commission has recognized that it is appropriate to grant in camera treatment for business records. In re Champion Spark Plug Co., 1982 FTC LEXIS 85, at *2 (April 5, 1982). When determining whether to grant motions for in camera treatment, administrative courts review six factors to determine secrecy and materiality of the exhibits at issue: (1) the extent to which the information is known outside of the applicant's business; (2) the extent to which it is known by employees and others involved in his business; (3) the extent of measures taken by him to guard the secrecy of the information; (4) the value of the information to him and to his competitors; (5) the amount of effort or money expended by him in developing the information; (6) the ease or difficulty with which the information could be properly acquired or duplicated by others. See In the Matter of Bristol-Myers Co., 90 F.T.C. 455, at *5-6 (Nov. 11, 1997).

## II. Respondents' Documents Meet the Clearly Defined, Serious Injury Standard

All six factors support granting Respondents' motion for in camera treatment. First, Respondents treat as confidential every document for which they seek in camera treatment. The information in these materials is not known to the public or generally outside OSF or RHS (or the party with whom the entities are negotiating or contracting). (See Sehring Decl. \| 4; Seybold Decl. ๆ 4.) These documents are not a matter of public record and have not been fully disclosed in any public context.

Second, the documents reflect the strategic decision-making of OSF and RHS senior executives. The information contained in the documents or discussed during the depositions is not generally disseminated throughout OSF or RHS. (See Sehring Decl. ๆ 4; Seybold Decl. ๆ 4.)

Third, OSF and RHS have carefully guarded the secrecy of their materials. The entities were compelled to produce the materials pursuant to the discovery process, but otherwise they have not publically disclosed the information found within the confidential documents or discussed during the depositions. (See Sehring Decl. §4; Seybold Decl. 『4.)

Fourth, competitor hospitals, such as SwedishAmerican, would benefit significantly from gaining access to these materials. The materials reflect OSF's and RHS' business strategies, finances and financial plans, budgeting scenarios, clinical quality reports, competitive goals, and contracting initiatives, all of which are competitively sensitive. For example, the materials include correspondence revealing negotiations with non-party managed care organizations ("MCOs"). These materials are competitively sensitive to OSF and RHS, as well as to the nonparties with which they contract. These documents represent a complex process and are unique to the relevant parties. Hospital competitors and other MCOs would benefit significantly and unfairly from gaining access to these materials.

Fifth, OSF and RHS have spent significant money in developing some of the materials, particularly financial budgets, strategic plans, and presentations created by third-party consultants. (See Sehring Decl. T4; Seybold Decl. I 4.) Respondents have hired consultants to assist them by analyzing their operations, financial performance, and potential strategies for future affiliations. Respondents have also hired experts to assist them with their defense in this matter. The public disclosure of this information would harm OSF's and RHS' business operations, their defense of this case, and, in the case of expert reports and related exhibits, reveal confidential non-party information.

Finally, it would be difficult for another party to replicate the information found in these materials because they reflect the work product of senior executives with years of experience in these organizations. The materials are unique and tailored to the respective entities and not known to the general public.

The tribunal may infer, "without a specific showing of how a competitor would use it, that disclosure of allegedly sensitive information would seriously affect the firm's commercial position. Underlying this analysis is a general concern for the seriousness of injury to a firm's commercial or competitive position." In the Matter of E.I. Dupont de Nemours \& Co., 97 F.T.C. 116, at *3 (Jan. 21, 1981). The materials at issue here pose a strong likelihood of harming the competitive position of Respondents, and certain non-party MCOs if disclosed to the public.

The information for which Respondents seek in camera treatment remains relevant and significant today. Respondents limit the documents for which they seek in camera treatment to those that are no older than four years. Nevertheless, even aged data is sensitive and remains worthy of protection because they reflect OSF and RHS business strategies, and can impact future negotiations between Respondents and MCOs. Disclosure of these materials would cause
competitive harm to Respondents and to non-party MCOs in future contract negotiations. See in re Kaiser Aluminum \& Chemical Corp., 103 F.T.C. 500, at *2 (May 25, 1984) (holding that material that was over five years old was still sensitive and deserving of in camera treatment where "a serious injury would be done by release of this information, which they have never made available to the public").

## III. Expiration Date

Respondents seek in camera treatment for a period of three years for the exhibits identified in Table I and testimony identified in Table 2. Where in camera treatment is granted for business records, it is typically extended for two to five years. See Evanston Northwestern Healthcare Corp., 2005 F.T.C. LEXIS 27, at *2 (Feb. 9, 2005); In re Union Oil Co. of Cal, 2004 FTC LEXIS 223, at *2 (Nov. 22, 2004); In the Matter of E.I. Dupont de Nemours \& Co., 97 F.T.C. LEXIS 116, 118 (Jan. 21, 1981) (granting financial data in camera treatment for three years); In re Int'l Ass. Of Conf. Interpreters, 1996 F.T.C. LEXIS 298 (June 26, 1996) (granting contracts in camera treatment for three years). Three years is necessary to protect Respondents' agreements with commercial health plans because those contracts often last several years. Three years is also necessary to protect business records with competitively sensitive information that contain projections or forecasts impacting future plans and initiatives. Therefore, documents that are three to five years old remain relevant, material, and confidential, and warrant in camera treatment.

## IV. Conclusion

Pursuant to 16 C.F.R. $\S 3.45$ and Paragraph 7 of the Scheduling Order, Respondents respectfully move for in camera treatment of the proposed exhibits listed in Table 1, and the designated testimony identified in Table 2.
