The papers of Count Adam G. de Gurowski, Polish scholar and author and advocate of Pan Slavism, were given to the Library of Congress by Frances G. Cumming in 1917.

Biographical Note

Count Adam G. De Gurowski was born the son of a Polish count in Kalisz, Poland, on September 10, 1805. After having his estates confiscated because of his objection to Russian influence in the area, he was later pardoned by Czar Nicholas I and invited to St. Petersburg. A graduate of the University of Heidelberg in Germany, de Gurowski went on to teach political economics at the University of Bern in Switzerland. In 1849, he arrived in New York and later lectured at Harvard University, Cambridge, Massachusetts, and joined the editorial staff of the *New York Tribune*. Ever interested in politics, de Gurowski made his way to Washington, D.C., where he supported the Union war effort and translated newspaper articles for the secretary of state. His diary was printed in 1862. De Gurowski died in Washington, D.C., on May 1, 1866, and is buried in the Congressional Cemetery.

Scope and Content Note

The papers of Count Adam G. de Gurowski (1805-1866) span the years 1743-1898, with the bulk concentrated in the period 1848-1898. The collection consists of correspondence, notes and drafts of books and articles, lectures, printed matter, photographs, and other papers relating primarily to de Gurowski's study of America; Code Napoléon (French civil law); Crimean War; ethnology; the philosophy of history; Hungary; Japhetians; New York, New York; Poland; Roman law; Russia; and the history of slavery. Includes manuscripts of Julius Bing's autobiography and his biography of de Gurowski. Some material is in French.
