

#### Steve DelBianco, Executive Director NetChoice Coalition

Steve DelBianco is an experienced business leader and policy expert in Internet and information technology. He ran an IT consulting firm before helping to start two tech policy groups: the Association for Competitive Technology, and NetChoice, a coalition of e-commerce businesses and consumers. In addition, Steve was an investor and board member of eRealty.com, a startup brokerage that empowered Realtors with Internet technology to better serve home buyers who want the convenience of online search and communications.

#### **Aaron Farmer, Texas Discount Realty**

After graduating with a degree in marketing from Texas A&M University in 1995, Aaron Farmer obtained a Texas real estate license and worked with a traditional brokerage franchise. Farmer started his own business, Texas Discount Realty, about five years later. In 2002, Texas passed what is commonly called a "minimum level of service" rule. Farmer challenged this new rule by filing suit against the Texas Real Estate Commission. Since then, Farmer has become a vocal leader of the "alternative" business model movement in Texas and around the country. He has been a frequent guest on various radio, TV, and national print media outlets. Today, Texas Discount Realty sponsors close to 50 licensed real estate agents with its sister company, National Agent Network, which Farmer founded as well.

## Robert W. Hahn, Executive Director, AEI-Brookings Joint Center

Robert Hahn is co-founder and executive director of the American Enterprise Institute-Brookings Joint Center, which focuses on regulation and antitrust. Previously, he worked for the Council of Economic Advisers. Dr. Hahn also has served on the faculties of Harvard University and Carnegie Mellon University. He frequently contributes to leading scholarly journals and general-interest periodicals, including the *American Economic Review*, *Yale Law Journal*, *Science*, and the *New York Times*. He is the author of *Reviving Regulatory Reform: A Global Perspective* (AEI-Brookings) and several other books. In addition, Dr. Hahn is co-founder of the Community Preparatory School—an inner-city middle school in Providence, Rhode Island, that provides opportunities for disadvantaged youth to achieve their full potential.

#### Philip Henderson, Vice President, LendingTree, LLC

Philip Henderson joined LendingTree in 1999 as legal counsel, where he helped to build the company's mortgage services business. As LendingTree expanded to include real estate services, Philip has held positions in both the legal and business strategy groups. Before coming to LendingTree, Philip was an associate with the law firm Kirkpatrick & Lockhart in Washington, D.C. working on mortgage banking matters. Philip received his law degree from the University of Virginia in 1993. RealEstate.com, operated by LendingTree, allows consumers to buy or sell a home through a suite of real estate services and tools, such as a personalized roadmap, more than one million home listings, Find-a-REALTOR® and Find-a-Builder services, home valuation tools, and customer care representatives.

#### Chang-Tai Hsieh, Associate Professor of Economics, University of California

Chang-Tai Hsieh is Associate Professor of Economics at the University of California, Berkeley. He previously held a position as Assistant Professor in the Department of Economics and the Woodrow Wilson School at Princeton University. Hsieh has published many papers in major economic journals, including "Can Free Entry be Inefficient? Fixed Commissions and Social Waste in the Real Estate Industry," in the October 2003 *Journal of Political Economy*. He is currently a Faculty Research Fellow for the National Bureau of Economic Research, Co-Chair for the World Bank Research Department Advisory Committee, and a Visiting Scholar at the Federal Reserve Bank of San Francisco. Hsieh graduated from the University of California, Berkeley with a Ph.D. in Economics in 1998.

#### Thomas R. Kunz, President and Chief Executive Officer, Century 21 Real Estate

Thomas R. Kunz was appointed president and chief executive officer of Century 21 Real Estate LLC in June 2004. The CENTURY 21® System is the world's largest residential real estate sales organization with more than 7,500 independently owned and operated franchised broker offices in more than 39 countries and territories worldwide. A 31-year veteran of the real estate industry, Kunz has spent two-thirds of his career affiliated with the CENTURY 21 System, where he established a successful track record involving franchise sales and ownership as well as running all aspects of brokerage and franchise operations. Since starting with the company in 1982, he has been responsible for everything from field communication, franchise sales, systems implementation, system-wide recruiting, broker automation and regional development.

At the state level, Cathy was the President of the Florida Association of REALTORS in 1996 and received the REALTOR of the Year award in 1998. She currently serves as one of nine commissioners on Florida's Commission on Ethics and also is a member of the state's Impact Fee Task Force. Cathy resides in Jacksonville with her husband Fred. They have 5 children and 7 grandchildren.
