SUBJECT: Amend Certification Under 1201 of the American Recovery Act

Dear Secretary LaHood:

Pursuant to Title XII, section 1201 of the American Recovery and Reinvestment Act P.L. 111-5 (February 17, 2009) ("ARRA") I, Felix P. Camacho, Governor of Guam certified Guam's maintenance of effort with regard to State funding for the types of projects in DOT "covered programs" funded under the ARRA on March 19, 2009.

The April 22, 2009 letters addressed to the Governors requested that in consideration of the additional guidance provided suggested a review of the submittal 1201 certification might be in order. A deadline of May 22, 2009 was imposed.

We provided an amendment on May 22, 2009. However, based on comments by the Federal Highway Administration, we are resubmitting the subject certification with a revised enclosure that lists the amount of funds Guam plans to expend from Guam sources from February 17, 2009 to September 30, 2010, for the types of projects under the DOT "covered programs" funded under ARRA.

I understand that if Guam is unable to maintain the level of funding identified in this list of the types of projects under the DOT "covered programs" Guam will therefore be prohibited by the Secretary of Transportation from receiving additional limitation on obligations for Federal-aid highway and highway safety construction programs after August 1 for fiscal year 2011.

This submission will supersede that dated May 22, 2009.
