Estimates for the thrifty food plan were computed from quantities of foods published in Family Economics Review, 1984, No. 1. Estimates for the other plans were computed from quantities of foods published in Family Economics Review, 1983, No. 2. The costs of the food plans are estimated by updating prices paid by households surveyed in 1977-78 in USDA's Nationwide Food Consumption Survey. USDA updates these survey prices using information from the Bureau of Labor Statistics: "CPI Detailed Report", table 4, to estimate the costs for the food plans.
